CL vs. Chat Rooms (pros)

- The offender is placing the ad
 - The investigation begins with the CL post
- With CL, less likely to be dealing with "fantasy communicators"
 - More likely dealing with an offender who has made his mind up to meet
- With CL, you're communicating with someone who resides in your jurisdiction
 - Or will be in your jurisdiction

CL vs. Chat Rooms (pros)


- The time between communication to an actual meeting is often very quick *
 - Patience of the offender
 - Time restraints they have (visitor in town)
- Turnaround time on subpoenas to CL is much quicker
 - Days versus weeks

CL vs. Chat Rooms (pros) • The majority of your offenders are identified prior to the meet – LE tools and email research tools are essential • TLO • NCMEC


CL vs. Chat Rooms (cons) Amount of grooming and or sexual communication is minimal compared to chat room investigations Can be a huge obstacle for your prosecutors Case begins with the CL post The time between communication to an actual meeting is often very quick** Patience of the offender Time restraints they have (visitor in town)
















Using CL to Identify the Poster CL provided information IP address Phone number associated with account Previous postings The most important information you can use Phone numbers Photos Other identifiers The key being different types of previous postings











Case Study • Replied to the ad as a 14 year old female • Communication later migrated to text message — Google Voice • Subject was very aggressive with sexual communication — Difficulties agreeing on a meet time — Subject failed to show up twice

Case Study • On his 3rd request to meet, it was over the Memorial Day weekend - Limited personnel was on duty - Decision not to deploy based on previous failed meetings

The Most Common Questions What is your script? What is the initial communication with subject? What do you do if the sexual communication is minimal?

The Script • Consider personifying a younger age - Prosecutors will want the wider age gap between the offender and "juvenile" • Different methods to personify younger - Pending birthday • "I'll be 14 years old in 2 more months" - "Next year I'll be a freshman" • Consider citing a dysfunctional home - "I live with aunt" - "I live with grandma"

The Script (cont)

- Cite concern of looking for "no drama"
- Make a decision on the juvenile's sexual history
 - Virgin?
 - Is it realistic a juvenile is looking through explicit online postings?
 - 1 to 2 sexual partners?
 - How old were these previous partners?
 - Are you willing to talk about these previous encounters?

The Script (cont)

- Does the juvenile attend school or are they homeschooled?
 - Attending school gives you more flexibility with communication
 - Attending homeschool may require more consistent communication

Initial Communication

- Typical intro
 - wat up,,,just saw ur post. U down 2 kick it wit sum1 a lot younger:)
 - Ohh snap,,,wat up boy. Down 2 kick it wit sum1 a lot younger??
- Introduction expecting no reply
 - Hey saw ur post and wanted to give u props,,,im wayyyy to young but still wanted to say hi:) byeeeee

What to do if Sexual Communication is Minimal

- Can pose a serious issue for your investigation
- Important to articulate what the original ad stated
- Methods of communication:
 - Arrange meeting during night time hours
 - Cite your concern of becoming pregnant at your personified age
 - Ask what you should wear






Reversal UC Operations • The majority of law enforcement efforts involve responding to suspicious posts - Replying to suspect who is looking to meet a juvenile • Reversal operations involves posting a Craigslist ad - Juvenile - Parent or guardian









Posing as a Good Samartian

- "Good Samaritan" posts a warning to other CL users
- Within minutes, replies begin to come in from people in "disgust", but wanting more details
 - They're provided limited information but assured the woman and her child are real
 - The email address to Mommy Zoe is provided as well
